

OFFICIAL PUBLIC NOTICE OF 2022 GENERAL ELECTION

The 2022 General Election will be held on Tuesday, November 8, 2022. Ballots will be mailed out to eligible registered voters, starting on October 18. Voters must be of legal voting age, citizens of the United States, and reside in the precinct in which they are registered.

Voters can verify registration status, and view a sample ballot online at www.vote.utah.gov. Registered voters who do not receive their ballot by **November 1** should contact the Elections Office.

The voter registration deadline to receive a ballot in the mail is October 28 at 5:00pm.

- In person voting will be held at the Weber Center (2380 Washington Blvd.) November 2, 3, 4, and 7 from 12:00pm to 6:00pm.
- Election Day at the Weber County Fair Grounds (Golden Spike Events Center 1000 N 1200 W, Ogden) and at Ogden Valley Library (131 S 7400 E, Huntsville) on November 8, from 7:00am to 8:00pm.

Ballot Drop Boxes are conveniently located at every city office, county library, in the Weber Center parking lot and on campus at Weber State University. Drop boxes are open 24 hours a day and until 8 pm on Election Day.

A public demonstration will be held on October 6 at 11:00am to test the voting system that will be used for the Primary Election. An audit of the Primary Election signatures will be held on November 18 at 11:00 a.m. Both of these will be held in the Elections Office on the first floor of the Weber Center, 2380 Washington Boulevard.

CONSTITUTIONAL AMENDMENT A

Shall the Utah Constitution be amended to change a provision relating to special sessions of the Utah Legislature that are convened by the president of the Utah Senate and speaker of the Utah House of Representatives:

- to increase the limit on the total amount of money the Legislature may appropriate during the session from an amount equal to 1% of the total amount appropriated during the preceding fiscal year to an amount equal to 5% of the total amount appropriated during the preceding fiscal year; and
- to exclude from that 5% limit:
 - an appropriation of money that the state receives from the federal government to address a fiscal, public health, or other emergency or crisis; and
 - an appropriation that decreases the amount of money previously authorized to be spent.

CITY OF HARRISVILLE BOND

Shall the City of Harrisville, Utah be authorized to issue general obligation bonds to acquire and construct a recreation facility in the City, in an amount not to exceed \$6,000,000 and to mature in no more than 26 years from the date or dates of such bonds?

Property Tax Cost of Bonds

If the bonds are issued as planned, a property tax sufficient to pay debt service on the Bonds will be required over a period of 26 years in the estimated amount of \$105.66 per year on a \$320,000 primary residence and in the estimated amount of \$192.13 per year on a business or secondary residence having the same value.

The foregoing is only an estimate and is not a limit on the amount of taxes that the governing body may be required to levy in order to pay debt service on the bonds. The governing body is obligated to levy taxes to the extent provided by law in order to pay the bonds.
