MINUTES HARRISVILLE CITY COUNCIL November 15, 2022 363 West Independence Blvd Harrisville, UT 84404

Minutes of a regular Harrisville City Council meeting held on November 15, 2022 at 7:00 p.m. in the Harrisville City Council Chambers, 363 West Independence Blvd., Harrisville, UT.

1. CALL TO ORDER

Mayor Tait called the meeting to order and welcomed all in attendance.

2. OPENING CEREMONY

Mayor Tait opened the meeting with the pledge of allegiance.

3. CONSENT ITEMS

a. Approval of the minutes for October 11, 2022, as presented.

MOTION: Council Member Weiss made a motion to approve the meeting minutes for October 11, 2022 as presented, second by Council Member Loveland.

The vote on the motion was as follows:

The motion passed unanimously.

4. RECOGNITION/AWARDS

a. Dennis Moore, Assistant Police Chief, presented the 'Award of Outstanding Support' to the Jason W. Read Protect and Serve Foundation in appreciation for their ongoing support. The generous contributions from the foundation have enabled the Harrisville Police Department to purchase necessary supplies, gear, safety equipment, and more.

5. OATH OF OFFICE

Police Chief Wilson congratulated Officer Clark on his promotion to Master Officer due to exemplary work.

The Oath of Office was administered to Detective Clark by Maria Devereux, City Recorder.

6. BUSINESS ITEMS

a. Discussion/possible action to adopt Harrisville Resolution 22-19; a resolution approving an Interlocal Agreement with Weber County for the distribution of Coronavirus State and Local Recovery Funds for the construction of a new Children's Justice Center, second by Council Member Wilhelmsen.

Chief Wilson noted this item has come before the council previously. Upon further research and discussion, he recommends the Council to approve funding for the new CJC building at the request of the County. All surrounding municipalities will utilize the center in their course of work.

MOTION: Council Member Weiss made a motion to adopt Harrisville Resolution 22-19; a resolution approving an Interlocal Agreement with Weber County for the distribution of Coronavirus State and Local Recovery Funds for the construction of a new Children's Justice Center as outlined, in the amount not to exceed \$39,116.00, second by Council Member Wilhelmsen.

The vote on the motion was as follows:

The motion passed unanimously.

Discussion/possible action to purchase radios for the Harrisville Police Department.

b. Dennis Moore, Assistant Chief, explained the City is able to work with Utah Communication Authority (UCA), although grant funding is limited, they were able to garner \$318.00 per radio. If the department purchases through their program now, Harrisville Police Department receives an approximate 60% savings. He would like to secure the radios needed currently, with consideration for future growth. The amount for 33 radios is

\$117,671,23. The City has to place a pre-order to secure the order, though has no other details in regard to the timeline, it could be September 2023 or 2024.

Mayor Tait asked for clarification on what will be done with the radio's they currently have and what is needed.

Dennis Moore noted, the current car radio's are in need of being updated, they are unable to get parts for them anymore and they need encryption software. The department may be able to sell them at approximately \$1000.00 each, are unable to be updated with encryption. The currently radios they have they may be able to sell and put toward the cost of this purchase. The new radios have the feature of connecting with FirstNet, this would give the radio's a larger range of full connectivity and functionality. New radio's have an approximate cost of \$2600.00 each. He explained that a one-time purchase should be good for at least 20 years, with purchase of a warrantee for each radio as well. The city needs to pre-order to place a tentative order and lock in at a lower rate. However, if the Council decides not to purchase, the city will still need to put encryption on the radios. The radio's would likely be delivered toward the end of 2023/2024.

MOTION: Council Member Weiss made a motion to authorize the purchase of new radios for the police department as presented, in the amount of \$172,671.23, second by Council Member Jackson.

The vote on the motion was as follows:

The motion passed unanimously.

7. PUBLIC COMMENT

Jessica Powell explained there is lack of protection as multiple kids are trying to get to the Jr. High School, at the west end of 2000 there is no crosswalk or flashing lights, much of this is due to construction. She requested the city add sensors, or provide a safe way for kids to cross the road.

8. MAYOR/COUNCIL FOLLOW-UP

Bryan Fife, Parks and Recreation Director, gave an overview of the work performed in the month of November. The department puts up Christmas lights, clean up leaves in the parks, get snow removal equipment ready in the parks, schedules basketball, and is currently preparing for Santa in the cabin.

Chief Mark Wilson, gave an overview of the department. He advised Assistant Chief Moore is celebrating 15 years of service at Harrisville City this month. The department is currently in the process of hiring an officer, and will be holding interviews this week. Shop with a Hero is the first Saturday in December and local businesses have donated to the cause. The program is growing each year. Safe routes to school is being addressed.

Jennie Knight, excused Justin Shinsel, Public Works Director. His department is ready for snow, the plows are ready.

Maria Devereux, City Recorder, gave an update on the Ashlar Cove Annexation, the certification was received from the Lieutenant Governor's office and will be recorded.

Jennie Knight gave an update on the following:

The Canvass election results will be in next week and the Canvass meeting will be held on Nov. 22, 2022 at 7PM.

Save the Date: A work session to be held January 24th, 2023 from 6-9PM to set goals and review strategies. The City Council, Planning Commission, and Weber Co. Economic Development will all participate.

A RAMP grant may be utilized to replace playground equipment. Private donations are welcome.

The City Christmas party (potluck) will be held on Dec. 1st at 6PM at the Cabin.

Council Member Weiss expressed thanks for a fantastic Fall Festival and asked the cost of more fireworks. Bryan Fife noted they were already paid for 2023.

Council Member Loveland noted appreciation for staff, those that donated, and attended the Fall Festival.

Council Member Jackson gave thanks to everyone involved in making the festival successful. He noted they ran out of ketchup and mustard for the hot dogs.

Mayor Tait thanked the staff and specific departments for their good work with the Fall Festival.







WHEREAS, the City adopted its Fiscal Year 2023 budget previously and desires to amend that budget according to the terms of the amended budget presented herein, with the referenced changes;

WHEREAS, Title 10, Chapter 6, of the *Utah Code Annotated* provides the procedure for the City to amend its budget;

WHEREAS, the legislative body, in accordance with state law, held its public hearing on December 13, 2023, to take public comment regarding the amended budget for the above referenced fiscal year and such budget was presented as contained herein;

NOW, THEREFORE, be it resolved by the City Council of Harrisville City as follows:

Section 1. Budget Amendment.

That the Harrisville City Council amends the budget for FY 2023 as per the attached budgetary forms incorporated herein by this reference, with the changes indicated therein.

Section 2. Compliance and Submission.

That staff is authorized to make any modification to said budget to conform with the submission requirements of state law. That said amended budget adopted herein in accordance with the requirements of the laws of the state of Utah shall be immediately forwarded by staff to the State Auditor within thirty (30) days.

Harrisville Ordinance 538 Right-of-Way Fees Amended December 12, 2022

To: Harrisville City Council

RE: Ordinance 538; Right-of-Way Fees Amended

A. Summary.

The city's right of way fees are assessed in accordance to HCMC §1.85.020 to protect the encroachment in the public right of way and to protect the infrastructure.

B. Background and Anaylsis.

In October of 2020, the right of way fees were repealed and reenacted to protect the city's infrastructure from other entity's encroachment on the public right of way. Since then, the city has noticed a need for some flexibility toward those entities who have a direct relationship with the city by providing services to our residents within the city's public right of way and "self-perform" the work themselves and not by hiring a third-party contractor. The proposed ordinance amends the Right-of-Way Fees to allow for the Public Works Director to use discretion with the type of work and impact to the public right of way and assess the appropriate fee accordingly.

C. Recommendation.

Staff recommends adopting Ordinance 538; Right-of-Way Fees Amended.



HARRISVILLE CITY ORDINANCE 538

RIGHT-OF-WAY FEES AMENDED

AN ORDINANCE OF HARRISVILLE CITY, UTAH, AMENDING SECTION 1.85.020 RELATING TO RIGHT-OF-WAY FEES; MAKING TECHNICAL CHANGES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Harrisville City (hereafter referred to as "City") is a municipal corporation, duly organized and existing under the laws of the State of Utah;

WHEREAS, *Utah Code Annotated* §10-8-84 and §10-8-60 authorizes the City to exercise certain police powers and nuisance abatement powers, including but not limited to providing for safety and preservation of health, promotion of prosperity, improve community well-being, peace and good order for the inhabitants of the City;

WHEREAS, the City desires to meet the challenges resulting from infrastructure deterioration caused by encroachments on the public right-of-way in the City;

WHEREAS, the City has an interest in protecting and preventing public funds from being used to pay for costly repairs and replacement of substandard construction by private parties;

WHEREAS, the City desires to recoup expenses incurred from right-of-way encroachment;

WHEREAS, the City deems it to be in the best interest of public health, safety, and welfare to allow coordination with local entities who "self-perform" utility installation, repair, and services;

NOW, THEREFORE, be it ordained by the City Council of Harrisville City as follows:

Section 1: Amend. Section 1.85.020 Right of Way Fees of the *Harrisville Municipal Code* is hereby amended as follows:

1.85.020 Right-Of-Way Fees

- 1) Permit. Encroachment permit requires a permit be filed with the Public Works Director. The Public Works Director is hereby delegated the authority to prepare the form and manner of the permit and outline the required information such as:
 - a. Applicant contact information.
 - b. Contractor performing the work.
 - c. Plans.
 - d. Traffic control.
 - e. Any other information necessary for the issuance of an encroachment permit.
- 2) Bond. The encroachment permit shall include a bond in an amount determined by the City Engineer but no less than \$10,000. The Public Works Director is hereby delegated the authority to waive the bond requirement for local entities who "self-perform" utility work without enlisting or contracting with a third-party.
- 3) Inspection. The City may conduct inspection and testing as needed to assure proper excavation, construction, and restoration.



- 4) Restoration. Applicant shall include a restoration plan that should include, among other things determined by the Public Works Director, the resurface of the area extending beyond the affected excavation where any surface treatment has been applied within the past two (2) years.
- 5) Fee. The fees for applications or projects involving the public right-of-way shall be as follows. The Public Works Director is hereby delegated the authority to reduce or waive the fee requirement for local entities who "self-perform" utility work without enlisting or contracting with a third-party.
 - a. Permit Fee: \$500.
 - b. Road Cut Fee: \$750, and 25 cents per square foot.
- 2) Other Right-of-Way Fees:
 - a. Road Boring Fee: \$500.
 - b. Curb, Gutter, and Sidewalk Cut: \$150.00
 - c. Subject to inspection by the City to assure that to a project meets the proper standards, fees are waived where a property owner is installing or replacing curb, gutter, or sidewalk.
- 3) Penalties. The following penalties apply:

- a. Civil. A violation of this section or operating without a permit under this section is a fine not to exceed \$1,000, per day, that a violation continues.
- b. Criminal. A violation of this section or operating without a permit under this section is a class B misdemeanor with a fine not to exceed \$1,000, per day, that a violation continues.
- Section 2: Severability. If a court of competent jurisdiction determines that any part of this ordinance is unconstitutional or invalid, then such portion of the ordinance, or specific application of the ordinance, shall be severed from the remainder, which shall continue in full force and effect.

 Section 3: Effective date. This Ordinance shall be effective immediately upon posting after final passage, approval, and posting.

Harrisville Resolution #22-23 Policy and Procedures Updates December 12, 2022

To: Harrisville City Council

RE: Resolution #22-23; Procurement Policy

A. Summary.

Staff has been reviewing policy and procedures over the course of the last nine (9) months and subsequently identified the need to adopt a procurement policy to protect city employees and allow for proper expenditure of municipal funds.

B. Analysis.

Although Harrisville City has historically monitored the purchasing of services and supplies as required in accordance with HCMC §1.08.050, to date the city has not yet adopted the "annual budgetary policies" referenced under this code. The proposed resolution creates responsible expenditure procedures for the purchasing of services and supplies outside of budgetary notes included in the adopted fiscal budget, including purchasing under emergency circumstances.

C. Recommendation.

Staff recommends adopting Resolution #22-23; Policy and Procedure Updates adopting a Procurement Policy in accordance with HCMC §1.08.050.

POLICY AND PROCEDURES UPDATES

A RESOLUTION OF HARRISVILLE CITY, UTAH, ADOPTING SECTION C-26 PROCUREMENT POLICY TO HARRISVILLE CITY PERSONNEL POLICIES AND PROCEDURES MANUAL; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Harrisville City (hereafter "City") is a municipal corporation duly organized and existing under the laws of the state of Utah;

WHEREAS, the City Council is authorized to adopt personnel policies and procedures for the effective and efficient administration of municipal government;

WHEREAS, the City Council adopted its current *Personnel Policies and Procedures Manual* on April 28, 2009, and has made various amendments to the same;

WHEREAS, the City Council desires to adopt a Procurement Policy to achieve greater efficiency and clarity;

NOW, THEREFORE, be it resolved by the City Council of Harrisville City, Utah, that the Policies and Procedures Manual Section C-26 Procurement Policy is hereby adopted to read as follows:

Section 1.

C-26 Procurement Policy

C-26-1 Purpose

To establish a procurement policy and procedures to govern purchasing practices for personnel.

C-26-2 General Purchasing Policy

- a. Purchases less than \$5,000 require Department Head approval.
- b. Purchases over \$5,000 up to \$10,000 require Department Head and City Administration approval.
- c. Purchases over \$10,000 up to \$25,000 require City Council approval.
- d. Purchase over \$25,000 require City Council approval and must be purchased under state bid or receive three (3) bids for the goods or services.

C-26-3 Fiscal Year Budget Purchasing Policy

Purchases approved in an adopted fiscal year budget where the purchase is outlined by a budgetary note may be purchased with Department Head approval.

C-26-4 Emergency Procurements



If a circumstance arises where the health, welfare, or safety of the public is threatened under emergency conditions, City Administration may authorize a Department Head to make emergency procurements or purchases.

Section 2.

Effective Date. This Resolution shall be effective immediately upon passage and adoption.
