RESOLUTION 22-22**

**A RESOLUTION APPROVING THE CANVASS OF THE
2022 GENERAL ELECTION**

WHEREAS, on November 8, 2022, the regular General Election was held; and

WHEREAS, on November 22, 2022, the City Council convened as the Board of Canvassers, to canvass the returns of the said General Election; and

WHEREAS, the City Council, during the canvass of the ballots, inspected the ballot results by precinct including any absentee ballots received by Election Day; and

WHEREAS, the City Council has determined that the election and voting were conducted in compliance with the law,

NOW, THEREFORE, be it resolved by the City Council of Harrisville City, Utah, as follows:

Section 1: The City Council, as the official Board of Canvassers, hereby accepts and approves the canvass reports entitled the ‘Summary Results Report’ to include the ‘Total Votes Cast’ for the 2022 Harrisville City Special Bond Election held on November 8, 2022.

Section 2: The Bond Proposition is declared to have received the number of votes indicated:

City of Harrisville Bond Proposition

AGAINST THE ISSUANCE OF BONDS – 1,849 Votes (85.72%)

FOR THE ISSUANCE OF BONDS – 308 Votes (14.28%)

Section 3: The Bond Proposition has failed to pass, having received an insufficient number of votes *for* the issuance of bonds.

Section 4. The City Recorder shall furnish a certified copy of this Resolution and copies of the Election Summary Report and Statement of Votes Cast to the Lieutenant Governor’s Office on or before the third Friday following the Municipal General Election.

Effective Date.

This Resolution shall be effective immediately upon passage and adoption.
